## Educational objectives

The degree course:

- Completes the basic and class specific education through courses taken in each scientific sector provided by the Ministerial Decree 25/11/2005, and grants the overall educational coherence of contents and educational objectives;
- Uses related and integrative subjects to connote the educational programme with respect to the professional sectors accessible after graduation;
- Ensures the coherence with and educational project developing technical and methodological profiles, in order to face the rapid obsolescence, as well as to grant the fertility of acquires knowledge and competences;
- Provides for, through ad hoc courses with special methodologies, the acquisition of sound knowledge and awareness of:
  - a) Institutional and organisational aspects of the legal system;
  - b) Professional deontology, legal and forensic logics and argumentation, legal sociology, legal computer science;
  - c) Legal language in at least one foreign language.

## Professional opportunities

The traditional professional ambit for jurists is the legal and judiciary profession, with the further possibility of spending their skills and abilities in companies and public institutions, national, supranational and international high level.

In addition to traditional employment opportunities of the law degree, the lawyer graduated at Agrigento can fit in international bodies, with reference to the figures of "legal experts in public bodies" and "managers of humanitarian cultural, scientific and sporting associations of national interest or supranational" given the specific internationalization of the course for the educational cycle 2013/2018.

The jurists graduates at Trapani might spend their knowledge and professionalism within the business also with reference to the figure of "legal experts in enterprise", given to the recent changes in the course outline, which aim to enhance the relationship with the economic and productive world, through business internships, as well as through caring relationships with individuals representing local authorities, businesses and professional groups.
