PREREQUISITES	Good knowledge of English. Basic knowledge of historical, institutional, economic and legal foundations of both Italian and English Law.
LEARNING OUTCOMES	<ul style="list-style-type: none">- Knowledge and ability to understand: enhancing knowledge of comparative law (in English);- Capacity to apply acquired knowledge and understanding: helping the student to understand law from a different perspective than their domestic law and in a foreign language;- Ability of judgement: putting the student in a condition to independently assess the outcome of Comparative Law in a global perspective.- Ability to Communicate: provide students with the knowledge of the contemporary comparative law debate;- Learning ability: learning to deal with both the study of law in a transnational perspective and the legal categories of the common law.
ASSESSMENT METHODS	<p>Oral examination aimed at ascertaining the level of knowledge of the subject matters.</p> <p>The exam consists of a minimum of three questions.</p> <p>The evaluation will unfold as follows:</p> <p>Excellent (30 - 30 cum laude): good knowledge of the topics, excellent language skills, excellent capacity of analysis; the student is able to apply theoretical knowledge to real cases which are proposed to be analysed;</p> <p>Very good (26 - 29): good knowledge of the topics, good language skills, good capacity of analysis; the student is able to apply theoretical knowledge to real cases which are proposed to be analysed;</p> <p>Good (24 - 25): Basic knowledge of the main topics, good language skills, the student shows limited ability to apply theoretical knowledge to real cases which are proposed to be analysed;</p> <p>Satisfactory (21 - 23): the student does not show complete conceptual mastery of the main teaching topics, although showing to know the basic knowledge; he/she shows satisfactory language skills albeit with a poor ability' to adequately apply theoretical knowledge to real cases which are proposed to be analysed;</p> <p>Sufficient (18 - 20): minimal knowledge of the main teaching and technical language issues, limited or no capacity to adequately apply theoretical knowledge to real cases which are proposed to be analysed;</p> <p>Not sufficient: the student does not have an acceptable knowledge of the contents of the various topics on the agenda.</p>
EDUCATIONAL OBJECTIVES	<p>The lecture course on Comparative Law is aimed at enabling students to familiarise themselves with the challenges and controversies found in comparative law.</p> <p>Among the topics covered are: globalisation, legal culture, comparative law and diversity, economic approaches, competition between legal systems, legal families and mixed systems.</p>
